- ❖ All applicants must pass a background & credit verification check. Any felonies, evictions, or collections filed pertaining to property and/or space rentals will result in an automatic denial of the application. You may request a copy of the report obtained by providing a valid photo I.D. & must be picked up in person.
- Income qualification is a combined total household income of at least 2.5 times the monthly rent, before taxes.
- ❖ We are required to hardline your sewer connection within 30 days of your move-in date. Fees are as follows: 1 sewer line = \$130.00 // 2 sewer lines = \$160.00. This is a one-time fee only.
